As Director of Design and Construction Division for the Pacific Rim Region she is responsible for design and construction projects totaling over a billion dollars in annual funding. As Regional Chief Architect she is responsible for all facets of Design Excellence in all types of space that the region designs, constructs or leases. The Pacific Rim Region of General Services Administration encompasses four western states: California, Nevada, Arizona and Hawaii as well as all the Pacific Territories. The Pacific Rim portfolio consist of over 1,100 properties and reflects over 40 million square feet of space.

Ms. Ciprazo is one of the National Design Peers for GSA and has been the chairperson for the Lead Designer selections for projects such as the Los Angeles Federal Courthouse, the new Port of Entry in San Ysidro, CA and the U.S. Federal Courthouse in Las Vegas, NV. She was the GSA National Design Peer in the Lead Designer selection for the large development of the St. Elizabeth's Campus in Washington, D.C. for the Department of Homeland Security.

Before joining GSA, Ms. Ciprazo was a Campus Architect for the University of California at Davis and a Project Architect for the Department of the Navy. Her prior professional experience includes community design work and private sector work in design and construction. Ms. Ciprazo is a licensed architect and a graduate of the University of California at Berkeley in Architecture.
