Mr. Mark Hovatter Los Angeles Unified School District, Chief Facilities Executive

Mr. Hovatter is responsible for managing the \$27B school construction and modernization program. He has over 30 years of experience in project & construction management, maintenance & operations, construction contracting and civil engineering. He served in the U.S. Navy in construction-related posts for 23 years. After retirement from the Navy he was Director of Facilities Contracts at LAUSD and awarded more than \$5B in design, repair, new construction, architectural and engineering contracts. He served as Director of M&O for El Camino College District until 2009 and returned to LAUSD as Director of the Measure Q Bond Program, and later as Procurement Executive where he successfully merged the separate operations of Facilities Services Contracts and Procurement into the single Division of Procurement Services that awarded more than \$1.5B in contracts for goods and services, and construction annually. Mr. Hovatter assumed his position as Chief Facilities Executive July 1, 2012.
